#### **MUSIC PERFORMANCE**

Randy Greenwell has been an Educational Support Manager with Conn-Selmer since January 2017. He is the former Director of Bands and Performing Arts Department Chair, of the nationally recognized Lawrence Central High School Performing Arts Department, Indianapolis, Indiana. Under his direction, the Lawrence Central High School Marching Band was an eighteen-time Bands of America Grand National Finalist and a two-time Grand National Champion. The Lawrence Central High School Marching Band was a "2001 Sudler Shield"

award recipient and a four-time Class A Indiana State Champion. They participated in prestigious national events such as the Tournament of Roses and Macy's Thanksgiving Day Parades. His wind ensembles were consistent state finalists, being named ISSMA Concert Band State Champion on five separate occasions. In addition, the LC Jazz Ensembles were awarded honor band status at several jazz festivals throughout his tenure at Lawrence Central.

Randy was named a "Distinguished Citizen of Indianapolis" in 2001. He was inducted into the "Music for All/Bands of America Hall of Fame" as well as the "Phi Beta Mu Hall of Fame" in 2018. He actively judges for DCI, WGI, and Bands of America, guest conducts honor bands, and does clinics on a variety of music education topics across the country. Randy continues to serve as music arranger and program coordinator for several competitive bands around the country and is part of the clinician team for the Conn-Selmer Institute Marching Arts Workshop.

In 2019, The Greenwood Community Band, for which he serves as Music Director, performed at the opening session of the Conn-Selmer Institute. Randy is still an active trumpet player in Indianapolis, performing exclusively on Vincent Bach Stradivarius instruments.



# **MUSIC PERFORMANCE**

**Andy Sealy** is in his fourteenth year as Director of Bands at Hebron High School in Carrollton, Texas. The Hebron High School Band is a consistent Texas UIL "Sweepstakes" Winner, Bands of America Regional/Super Regional Finalist and Class Champion, and "Best in Class" Winner.

The Hebron Wind Symphony was recognized as the Texas Music Educators Association 5A Honor Band for 2010-2011 and performed for the 2011 TMEA Convention Clinic. The Hebron

Wind Symphony also performed at the 64th Annual Midwest Band and Orchestra Clinic in 2010 and was awarded the prestigious Sudler Flag of Honor from the John Philip Sousa Foundation in 2012. The Hebron Marching Band has earned six straight appearances in the UIL Texas State Marching Band Contest including three consecutive Silver Medalist finishes in 2012, 2014, and 2016. The Hebron Marching Band received the Sudler Shield in 2011 and in 2014 was the Bands of America Grand Nationals 4A Class Champion and overall Bronze Medalist. In 2009, the Hebron Clarinet Choir performed at the 63rd Annual Midwest Band and Orchestra Clinic. And, in 2014, all of the Hebron Large Chamber Ensembles performed at the 68th Midwest Band and Orchestra Clinic. The Texas Chapter of the American School Band Directors Association selected the Hebron High School Band for their 2015 Outstanding Program Award.

Andy is a frequent adjudicator and clinician. He maintains professional affiliations with the Texas Music Educators Association, Texas Bandmasters Association, Phi Beta Mu International Bandmasters Fraternity, American Bandmasters Association, Texas Music Adjudicators Association, International Clarinet Association, and Phi Mu Alpha Sinfonia. He currently serves as the President-Elect of the Texas Music Educators Association.



#### **GENERAL EFFECT**

**Darrin Davis**, a graduate of Broken Arrow High School, currently serves as the Director of Bands for the Broken Arrow school district and has enjoyed teaching band in the Broken Arrow Public Schools since 1993. Davis is responsible for guiding the 1500 band students and 12 band instructors within the school district. Mr. Davis is the conductor of the Broken Arrow HS Wind Ensemble and director of the nationally acclaimed Pride of Broken Arrow Marching Band. Davis' Broken Arrow bands have performed at Carnegie Hall, the Music for All National Concert

Band Festival, the Oklahoma Music Educators Convention, and have marched in the Tournament of Roses Parade (2009 & 2013). Twice, the John Philip Sousa Foundation has presented the Broken Arrow Marching Band the prestigious Sudler Shield (1999 & 2008). Broken Arrow is a 23-time Oklahoma State Marching Band Champion, a 13-time BOA Grand National Finalist, a 15-time BOA Regional Champion, and the 2006, 2011 & 2015 Bands of America Grand National Champion. Since he began teaching at Broken Arrow High School, every concert ensemble under Mr. Davis' direction has received the OSSAA Sweepstakes Award at the Oklahoma State Concert Band Festival. The Broken Arrow band program has a long tradition of excellence, having received the Oklahoma Secondary Schools Sweepstakes Award recognizing excellence on the concert stage and the marching field over 100 times.

Mr. Davis earned a Bachelor of Music Education degree at Missouri Western State University and a Masters of Music Education degree with wind conducting emphasis from the University of Tulsa. He has studied wind conducting with many of the premier conductors in America.

The Oklahoma Bandmasters Association honored Davis as their 2012 "Band Director of the Year." Mr. Davis is a national clinician and adjudicator for such organizations as Drum Corps International, Bands of America, the Fiesta Bowl National Band Championship, and numerous state band associations. Davis has served on the executive board for the Oklahoma Northeast Band Directors' Association and is an active member in NBDA, OBA, OMEA, and Music for All organizations.



#### **GENERAL EFFECT**

**Jay Webb** has been the Director of Bands at Avon High School in Avon Indiana since 1993. In that time the Avon Band has consistently been recognized as a leader in instrumental music education and pageantry activities.

The Avon Band programs many successes include multiple state (48) and national championships (13), including the Bands of America Grand National Championship in 2008, 2009, and 2010. The

Avon Marching Black and Gold was awarded the Sudler Shield in 2007 and performed in the Tournament of Roses parade in 2012.

All aspects of the Band program strive to achieve at the highest national levels with participation in Winterguard International, Bands of America, and Indiana State School Music Association events. In 2016 Avon was awarded their third State Concert Band Championship. In addition, the Avon Band program had two Instrumental groups perform at the Midwest Band and Orchestra Clinic in 2015 in Chicago Illinois.

Mr. Webb brings a variety of experiences ranging from performances with the award-winning drumline of the Bridgemen Drum and Bugle Corps from Bayonne New Jersey to the Indianapolis Symphony Orchestra. Mr. Webb is a graduate of Butler University. (B.M.E. 1991) Mr. Webb was inducted into the Winterguard International Hall of Fame in 2008 and the Indiana Percussion Hall of Fame in 2016.
